BEST PRACTICE PUBLIC-PRIVATE

- A workshop attended by RI representatives was held in Graz in June 2016
 to explore issues around access, quality, data and IP in relation to
 pre-competitive collaboration models. An external expert was
 commissioned by CORBEL to prepare a paper on IP issues in
 pre-competitive research.
- The meeting "How European BMS RIs boost Innovation by Open Access" (20 June 2017, Brussels) was organised to expand this theme together with industry and representatives from the EU Commission.
- A 2-day workshop including an extensive teamwork exercise has been held twice and will be repeated in Riga in April.
- The deliverable "Industry Collaboration Best Practice Guide" provides a guide on most aspects for the academic researcher and gives references to further practical information sources.



SOME OBSERVATIONS ON OUTREACH TO THE BIOMEDICAL INDUSTRY

- Primarily through existing networks
- Profiling Research Infrastructures takes time
- SMEs have highly specific needs in relation to their product pipelines
 - A few examples where a match was found with specific resources
 - The scope and scale of the RIs can be daunting for SMEs
 - Their needs often do not fit the "rules" for academic research programmes
- Larger companies take a longer term view and may be interested in strategic alliances with academia
- We have reached out to industry and this should be sustainable post-CORBEL
